# Security Issues

## High Severity Issues

## Low Severity Issues

### 1. Out of gas

Issue:

- ❑ In PacocaFarm contract the function `massUpdatePools` uses the loop to update reward variables. Function will be aborted with `OUT_OF_GAS` exception if there will be a long excluded pool list.

Recommendation:

Do not use long arrays.

### 2. Array length checking

Issue:

- ❑ `StratX2_CAFE`'s constructor expects `_addresses` parameter as an array with 12 items. Owner by mistake can provide the wrong array.

Recommendation:

Check the length of that array.

Smart contracts do not contain high severity issues.
